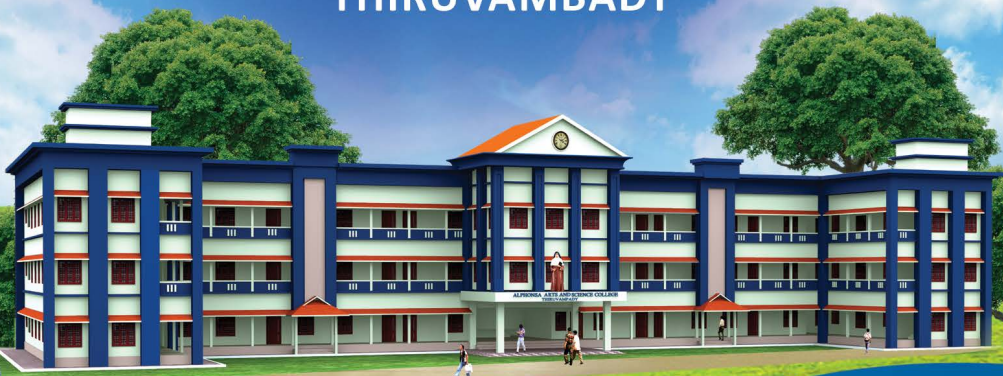

ST. ALPHONSA, OUR HEAVENLY PATRONESS

St. ALPHONSA was born in Kudamalur, in the diocese of Changanacherry, India, on 19th August 1910, to Joseph and Mary of the ancient and noble family of Muttathupadathu. Annakutty read the biography of St. Threse of Lisieux which instilled in her a strong desire to become a saint. Annakutty joined the clarist Convent at Bharananganam. Her vestition was held on 19th May 1930.

From her birth, the life of the Saint was marked by the cross, which was progressively revealed to her as the royal way to conform herself to Christ. With an attitude of a victim for the love of the Lord, happy until the final moment and with a smile of innocence always on her lips, St Alphonsa quietly and joyfully brought her earthly journey to a close in the convent of the Franciscan Clarists at Bharananganam at 12.30 on the 28th July 1946, leaving behind the memory of a Sister full of love and saintliness. She is buried at Bharananganam. Her tomb at Bharananganam turned into a great centre of pilgrimage attracting people from far and near.

In 1984 the Pope officially declared that Sr. Alphonsa had heroically practiced Christian virtues. A miracle wrought through her intercession was also formally approved by the Holy See on 16th July 1985. She was beatified by Pope John Paul II on 8th February 1986 at Kottayam and decided as a saint by the pope Benedict XVI on March 1 2008. It was officially declared on October 12, 2008.

St Alphonsa is the first Indian woman to be elevated to sainthood. All Indians are proud to have St. Alphonsa, the first Catholic saint in India, born of Indian parents, lived and sanctified her life in India. So, the college is proud to hold St. Alphonsa as the patron, for her great ideals of determination, sacrifice and commitment to the society. It preserves the memory of St. Alphonsa whose saintly life of love and service has always been an inspiration.



ABOUT US

The Diocese of Thamarassery, located in the northern mountainous region of Kerala inaugurated on 3rd July 1986 consists of two revenue districts of Kerala; Kozhikode and Malappuram. It consists of 113 parishes and 19 mission stations. Since its formation the Diocese of Thamarassery has always been paying attention to the pastoral needs of the faithful at various levels.

With the aim to provide education to the children irrespective of caste and creed the diocese started schools from lower primary to the higher secondary level. The diocese has formed an educational trust for this purpose by the name- Educational Trust of the Diocese of Thamarassery. At present the trust has started a higher education college that gives continuity to the educational services of the Diocese. In the year 2014 the Diocese started its first higher educational institution; Alphonsa College Thiruvambady (ACT), obtaining permission from the government of Kerala. The college provides an excellent atmosphere for education and training in various disciplines to youngsters of all communities. Its prime responsibility is to mould the students as the future citizens of India. On 28 July, 2014 the first academic year was inaugurated at the Cherubin Memorial Parish Hall, Thiruvambady.

The college was shifted to its new edifice on 28th July 2015 and was officially inaugurated on 22nd January 2016 by the Honorable Chief Minister Shri. Oomen Chandy. The present site is about 2 kilometers away from

Thiruvambady town, located on top of the region which is a lush greenery. Alphonsa College Thiruvambady is the one and only college for higher studies for the students of remote mountainous villages of this area of Calicut district. ACT is affiliated to the University of Calicut. The college provides an excellent atmosphere for education and training in various disciplines. It provides six courses and it has total intake of 300 students per year. The college in its third academic year is well equipped to consist the students with all educational requirements. The college admits youngsters of all communities irrespective of caste, creed and gender to be courageous, truthful and well-balanced to face the challenges of the present day world.

The holistic development of each and every student at ACT is the responsibility of the college. Numerous programmes that promote overall development of the students are organized in ACT. This institution pursues excellence in its molding of the future citizens of India. These programs cover a wide range of areas of both academic and non-academic interest.

GENERAL NORMS

ATTENDANCE

- The university prescribes a minimum of 75% attendance. The college insists on regular attendance in all classes. So unless there is a real necessity, no one should absent oneself from classes.
- When absents from class, a leave letter duly signed by the parent or guardian should be presented to the tutor in advance. If the absence is due to any unforeseen circumstance, the leave letter should be submitted on the day of return.
- Students going for cultural competitions and other extra-curricular activities as on duty should get prior permission from the Principal through the Coordinator of these programme.
- The attendance shall be communicated to the students at regular intervals.
- Frequent absence shall be reported to the Guardian. .
- Failure to observe rules regarding the attendance will entail the loss of attendance and this may disqualify the student from appearing for the University Examinations.

POINTS OF POLITENESS

“Good manners are expressions of a refined character

ACT shall aim at observing certain norms of polite behavior:

- Always be punctual in attending to various chores and classes.
- When a Lecturer enters the class, gently rise and remain standing till he/she give signals to be seated.
- Practice and promote respect and cordiality among the students and the staff.
- Handle the college property with care.
- Do not disfigure walls and furniture.
- It is part of politeness to offer to make good the damage done to any college property.
- During class hours, students shall not be found loitering anywhere on the college campus. Transacting any work in the college campus during class hours is to be avoided by all.
- After the second bell, strict silence is to be observed in the class by all the students. If the lecturer happens to come late, students shall maintain silence inside the class.

- During free hours, students are expected to make good use of the library.
- Insubordination to Lecturers, habitual neglect of class work, vulgarity in word and deed, deliberate vandalism, stealing, being a nuisance in the class, habitual neglect of study are sufficient reasons for disciplinary action.
- Only the electronic items which are necessary in persuasion of the course are allowed to be brought to the college and used as per the directions of the Lecturers.
- Do not use mobile phones in the College Campus.
- Obscene books and periodicals, smoking, use of alcohol and drugs in any form, are strictly forbidden in the college campus.
- Leave the toilets clean after use.
- The students are forbidden to bring transistors, crackers, explosives and other dangerous materials to the College.
- The Government and the University have issued detailed instructions with regard to the banning of any sort of RAGGING on the college campus by any student.
- Instant dismissal is the usual punishment for any offenders in this regard.
- Queue up at counters waiting for your turn without usurping the turn of others.
- The Students are expected to come in uniform. Let your person and dress be neat and clean without show. Personal cleanliness, overall smartness, the neatness of the class rooms and cleanliness and beauty of the college campus need to be maintained.
- Let your parents and guardians be proud of your conduct at home and in society.
- Be aware of the massive amount of sacrifice that your parents and the nation are making for your all round education.

LIBRARY AND READING ROOM

- Maintain absolute silence in the Library.
- The College will provide library cards for students.
- The filled in application slips should be handed over to the librarian.
- Books will be issued only on presentation of the Library card of the student on which his/her photograph has been affixed.
- For all students a maximum of two books at a time will be allowed.
- No one is allowed to sub lend the library books, he/she has borrowed, nor get the books on behalf of another.

- The borrower will be held responsible for any damage done to the books which he/she borrows and in case of serious damage done to the books; he/she will be asked to restitute the damaged book.
- Therefore before leaving the library counter, the student must carefully check the books issued to him/her. If any damage is noticed, it must be reported to the Librarian at once, lest he should be held responsible for it later on.
- The loss of library books should be immediately reported to the Librarian.
- Books must be returned to the library on or before the due date stamped on them. If not, overdue charge of Rs.10/- per book per day will be collected from the defaulter.
- Reference books, papers and periodicals shall not be removed from the Reading Room or from the places allotted for them.
- No books will be issued to those who have not cleared their overdue charges in full.

HINTS FOR EFFECTIVE STUDY

Association with students who are earnest in their studies is a great help to study. No amount of private study or tuition can substitute active listening in class. Avoid private tuition, which reduces self-confidence and initiative. All assignments should be done neatly upto date. Note down the work assigned for the next day. Never omit a lesson or any assignment given. Revise the work done in class daily. Set aside a fixed time for daily study at home. Remember that asking questions is the key to learning. Never hesitate to ask questions about the subject matter in and out of class. When studying, ready yourself to explain the lesson to another. Pray to God, the source of your talents, for the grace to discover and develop them. Remember that 'a stitch in time saves nine'.

MENTORING SYSTEM

A C T has implemented an effective mentoring system for the students. It aims at promoting better understanding between the teacher and the students and thus to facilitate the moral spiritual and intellectual well-being of the students. A class is under the personal care of a Lecturer (Mentor), who meets them in group on a regular basis. Students are encouraged to meet the mentor for proper guidance and counseling. The Mentor keeps contact with parents as well. By the interaction of the Parents, Teachers and the Students (PTS), the overall growth of the student are taken care of.

RECOMMENDATION TO PARENTS

The active involvement of parents in the education of their children is very much required in this modern era. This is achieved through the interaction of parents with the teachers and the College Authorities. Class wise parents meetings are held in every term after the exams for analyzing the results and the general performance of the student in the College and at home. Occasional visits of parents to the College and dialogue with the authorities especially the mentor is very much encouraged. These visits and the interaction with the authorities are to enhance the overall development of the students. To encourage this and to attend to the requests of the parents, records are maintained in the College for the Parents by the Mentor. The College Administration checks these and addresses the issues regularly

EXAMINATIONS AND REPORTS.

Besides the regular class tests there will be official terminal examinations conducted in common for the students on the dates specified in the Handbook. Attendance at examination is compulsory. Students not appearing for the examination without prior permission from the Principal will be seriously dealt with and fined

EVALUATION AND GRADING

Mark system is followed instead of direct grading for each paper.

The evaluation scheme for each course shall contain two parts

1) Internal assessment 2) External Evaluation

20% weight shall be given to the internal assessment. The remaining 80% weight shall be for the external evaluation.

INTERNAL ASSESSMENT

20% of the total marks in each course are for internal examinations. The internal assessment shall be based on a predetermined transparent system involving written test/assignments/seminars/viva and attendance in respect of theory courses. Components with percentage of marks of Internal Evaluation of Theory Courses are Attendance 25%, Assignment/Seminar/Viva 25% Test paper 50%.

Internal assessment of the project will be based on its content, method of presentation, final conclusion and orientation to research aptitude.

THE KERALA PROHIBITION OF RAGGING ACT, 1998

(Act 10 of 1998)

An Act to prohibit ragging in educational institutions in the State of Kerala.

Preamble:- WHEREAS it is expedient to prohibit ragging in educational institutions in the State of Kerala.

BE it enacted in the Forty-Ninth Year of the Republic of India as follows:-

1. *Short title, extent and Commencement.*
 - (1) This Act may be called the Kerala Prohibition of Ragging Act, 1998. 46
 - (2) It extends the whole of the State of Kerala.
 - (3) It shall be deemed to have come into force on the 23rd day of October, 1997.
2. *Definition:* - In this Act, unless the context otherwise required,-
 - (a) 'Head of the educational institution' means the Principal or the Headmaster or the person responsible for the management of that educational institution;
 - (b) 'Ragging' means doing of any act, by disorderly conduct, to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or fear or shame or embarrassment to that student and includes-
 - (i) teasing, abusing or paying practical jokes on, or causing hurt to, such student; or
 - (ii) asking a student to do any act or perform something which such student will not, in the ordinary course willingly, do.
3. *Prohibition of ragging:*- Ragging within or without any educational institution is prohibited.
4. *Penalty for ragging:*- Whoever commits, participates in, abets or propagates ragging within, or without, any educational institution shall, on conviction, be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.
5. *Dismissal of student:*- Any student convicted of an offence under section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other edu-

cational institution for a period of three years from the date of order of such dismissal.

6. *Suspension of student:-* (1) Whenever any student or , as the case Amy be, the parents or guardian, or a teacher of an educational institution complaints, in writing, of ragging 47 to the head of the educational institution, the head of that educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately, forward the complaint to the police station having jurisdiction over the area in which the educational institution is situate, for further action.

(2) Where, on enquiry by the head of the educational institution, it is proved that there is no substance prima facie in the complaint received under sub-section (1), he shall intimate the fact, in writing, to the complainant.

7. *Deemed abetment:-* If the head of the educational institution fails or neglects to take action in the manner specified in section 6 when a complaint of ragging is made, such person shall be deemed to have abetted the offence of ragging and shall, on conviction, be punished as provided for in section 4.

8. *Power to make rules:-* (1) The Government may, by notification in the Gazette, make rules for carrying out all or any of the purposes of this Act.

(2) Every rule made under this Act shall be laid, as soon as may be after it is made, before the Legislative Assembly, while it is in session for a total period of fourteen days, which may be comprised in one session or in two successive sessions, and if before the expiry of the session in which it is so laid, or the session immediately following, the Legislative Assembly makes any modification in the rule or decides that the rule should not be made, the rule shall, thereafter, have effect only in such modified form or be of no effect, as the case may be, so, however that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule. 48

9. *Repeal and saving:-*(1) The Kerala prohibition of Ragging Ordinance, 1998 (2 of 1998) is hereby repealed.

(2) Notwithstanding such repeal, anything done or deemed to
