
Graph VIII:. employers feedback regarding the relevance of curriculum in terms of real life application shows that most of them have very good and good comments. 34% rated for very


good and 33 percentage voted for good option. But remaining 34% have only average opinion about the same.












Graph IX: 67% employers give excellent and 33% employers give good comments about the abilities of the curriculum in developing practical solution to work place problems.






